I _____ as the legal owner/agent of the above mentioned dog(s), having carefully read and fully understanding this agreement, do hereby waive and release New England K9 Athlete and its affiliates from any and all liability of any nature. This includes any injury; death, sickness or damage myself or my pet may suffer during or resulting from these activities. I understand the risk of injury resulting from possible malfunction of the pool, dock, and or the risk of injury resulting from obstacles in the pool area. I also agree to indemnify and hold harmless New England K9 Athlete, from any and all claims due to damage the pet may cause to any family members or any third parties during or resulting from training or exposure to other dogs. I understand that any damages done to the pool or dock by my dog or myself will be my sole financial responsibility to repair at cost. I understand that any damages done must be reported or I will forfeit my rights to rent at New England K9 Athlete.

I certify that my dog is in good health, and agree to follow these rules as outlined below:

- Dogs in heat will not be allowed on the dock or on premise. If a dog is found to be in heat, it is the responsibility of the handler to immediately remove the dog from the swimming area and disinfect all areas where the dog was present.
- Should the dog appear to be injured or ill, the dog's handler will be asked to cease activities until such time as the dog regains health. Examples of injury include limping/lameness, bandages, stitches, and open wounds (including hot spots).
- Should the dog be known to have had a recent injury a letter from an accredited veterinarian, stating the dog may partake in swimming as a part of rehab, must be presented prior to pool use. _____

Control and Containment:

- All dogs must be crated or held by the handler or an assistant of the handler on a six (6) foot lead at all times while on site.
- Dogs may potty outside the fenced in area (gravel area to the right of the parking lot) or in the back fenced in potty area. DO NOT allow your dog to potty in the dock area, this includes on the sides of the pool and bottom of the dock. Dogs must be on leash when entering the fenced in pool area and maybe taken off leash when they get to the back fenced potty area or once they are on the dock.
- Owners and handlers must control their dogs at all times. If you are unable to control your dog you will be required to leave the premises; no fees or purchases will be refunded.
- Prong collars, choke collars, and chain martingales maybe used getting onto the dock, but once the dog is off-leash these collars must be removed simply because they can get caught on the ramp or other items in the dock/pool area and pose a safety hazard.

- Dogs must be kept on a leash that is six (6) feet long or SHORTER at all times while on New England K9 Athlete grounds. Once the dog is in the off-leash area (on the dock or in the back fenced potty area) you may use a long lead if needed. You are responsible for having control over your dog at all times.
 - We have some life-vests available here, but to ensure there is one that fits your dog appropriately we ask you bring your own.

Media Release

Photographs or videos are often taken of dogs at New England K9 Athlete. I hereby release such media and give New England K9 Athlete permission to use any such material for training, advertising or other promotional purposes.

Dock Etiquette and Rules

- Please have your dog shake off excess water in the area above the ramp before stepping back onto the dock to minimize the water pools on the turf.
 - Take midswim potty breaks to help reduce the chance of a pool or dock accident. You can use the back fenced in area or outside the fenced in area. **PICK UP AFTER YOUR DOG.**
 - If your dog has an accident on the dock or in the pool please notify the staff immediately. You are responsible for the cost associated with cleaning up accidents: \$200 for accidents in the pool.
 - We can supply toys for Air Retrieve, Extreme Vertical, Speed Retrieve, and Hydrodash. However if your dog destroys one of our toys you are responsible for paying \$20 to replace the toy (due at time of destruction).
 - Failure to report an accident results in forfeiture of my rights to rent at New England K9 Athlete. The pool has outdoor security cameras that are monitored.
 - All children under the age of 12 must be accompanied by an adult on the dock.
 - All children under the age of 18 must have their parents consent/waiver signed.
 - **If you wish to enter the pool with your dog you may only do so during a lesson appointment NOT during a rental due to liability reasons.** By signing this form you understand the risk of entering the pool with your dog and waive and release New England K9 Athlete and its affiliates from any and all liability of any nature as previously stated above.
 - Excited dogs bark! But please try to keep excessive barking under control to respect our neighbors.

Rental Agreement: If you are renting the pool (i.e. no direct supervision or instructor): I hereby state that my dog does know how to swim and I assume all responsibility for my dog's actions while in the pool area not limited to accidents, destruction, injury etc.

Cancellation or No Show:

Client will be billed 100% of the total charge of their scheduled swimming appointment if the client doesn't notify us to cancel within 48 hours from their appointment time (this includes in-climate weather such as rain). If there is thunder or lightning then pool appointments will be rescheduled.
